## 淡江大學個人資料公務使用同意書

本同意書說明淡江大學國際暨兩岸事務處境外生輔導組（以下簡稱本組）將如何處理本組所蒐集到的個人資料。

當您勾選「我同意」並簽署本同意書時，表示您已閱讀、瞭解並同意接受本同意書之所有內容及其後修改變更規定。若您未滿二十歲，應於您的法定代理人閱讀、瞭解並同意本同意書之所有內容及其後修改變更規定後，方得使用本服務，但若您已接受本服務，視為您已取得法定代理人之同意，並遵守以下所有規範。

### 一、基本資料之蒐集、更新及保管

1. 本組蒐集您的個人資料在中華民國「個人資料保護法」與相關法令之規範下，依據本校【隱私權政策聲明】，蒐集、處理及利用您的個人資料。
2. 本組因執行業務所蒐集您的個人資料包括姓名、原屬機構、護照號碼、身份證字號/居留證號/統一編號、生日、國籍、聯絡方式(電話、E-Mail)等，請於申請時提供您本人正確、最新及完整的個人資料。若您提供錯誤、不實、過時或不完整或具誤導性的資料，您將損失相關權益。
3. 您可依中華民國「個人資料保護法」，就您的個人資料行使以下權利：  
(1)請求查詢或閱覽。(2)製給複製本。(3)請求補充或更正。(4)請求停止蒐集、處理及利用。  
(5)請求刪除。

但因本組執行職務或業務所必須者，本處得拒絕之。

若您因行使上述權利，而導致權益受損時，本處將不負相關賠償責任。

### 二、蒐集個人資料之目的

1. 本組為執行輔導業務之相關作業所需。
2. 當您的個人資料使用方式與當初本組蒐集的目的不同時，我們會在使用前先徵求您的書面同意，您可以拒絕向本處提供個人資料，但您可能因此喪失您的權益。
3. 本組利用您的個人資料期間為即日起 10 年內，利用地區為台灣地區。

### 三、基本資料之保密

您的個人資料受到本校【隱私權政策聲明】之保護及規範。本處如違反「個人資料保護法」規定或因天災、事變或其他不可抗力所致者，致您的個人資料被竊取、洩漏、竄改、遭其他侵害者，本組將於查明後以電話、信函、電子郵件或網站公告等方法，擇適當方式通知您。

### 四、同意書之效力

1. 當您勾選「我同意」並簽署本同意書時，即表示您已閱讀、瞭解並同意本同意書之所有內容，您如違反下列條款時，本組得隨時終止對您所提供之所有權益或服務。
2. 本組保留隨時修改本同意書規範之權利，本組將於修改規範時，於本組網頁(站)公告修改之事實，不另作個別通知。如果您不同意修改的內容，請勿繼續接受本服務。否則將視為您已同意並接受本同意書該等增訂或修改內容之拘束。
3. 您自本同意書取得的任何建議或資訊，無論是書面或口頭形式，除非本同意書條款有明確規定，均不構成本同意條款以外之任何保證。

### 五、準據法與管轄法院

## TKU Consent to Provide Personal Data

This consent letter (this "Consent") sets forth how Office of International and Cross-Strait Affairs, International and Mainland Student Guidance Section, Tamkang University

("OICSA, IMSGS, TKU") will process the personal data collected hereunder.

By ticking the "I agree" box and signing this Consent, you confirm that you have reviewed, understood, and agreed to the terms of this Consent and its amendments. If you are under the age of 20, you cannot use the service until your legal guardian has reviewed, understood, and agreed to the terms of this Consent and its amendments. Nevertheless, you will be deemed to have obtained your legal guardian's consent and agreed to comply with the following terms if you have used the service.

### A. Collection, Updating, and Custody of Personal Data

1. OICSA, IMSGS, TKU will collect, process, and use your personal data in accordance with the Personal Data Protection Act and other relevant laws and regulations as well as TKU's Privacy Policy.
2. To practice our duty, we need to collect the personal data, including your name, institution, passport, ARC ID, date of birth, nationality, and contact information (phone numbers or email) from you. You are asked to provide the most correct, updated, and completed personal data when you fill out the application. Your rights and interests may be affected if you provide OICSA, IMSGS, TKU with false, outdated, partial, or misleading personal data.
3. You may exercise the following rights as regards your personal data in accordance with the Personal Data Protection Act: (a) inquire or review your personal data; (b) ask for duplicates of your personal data; (c) ask to supplement or correct your personal data; (d) ask to stop collecting, processing or using your personal data; and (e) ask to delete your personal data.  
OICSA, IMSGS, TKU may refuse your request(s) in order to perform its duties or conduct its business.  
OICSA, IMSGS, TKU will not compensate any loss or damage you may sustain from the exercise of such rights.

### B. Purposes of Collecting Personal Data

1. In order to process international and mainland students through TKU, OICSA, IMSGS, personal information must first be submitted.
2. OICSA, IMSGS, TKU will ask for your written consent in advance if your personal data needs to be used for any other purpose. You may refuse to provide your personal data, but you may lose your rights or interests accordingly.
3. OICSA, IMSGS, TKU may use your personal data in Taiwan for a period of 10 years commencing from now on the date of submitting your application.

### C. Protection of Personal Data

Your personal data is protected by TKU's Privacy Policy. Please review the Privacy Policy for its full text. If OICSA, IMSGS, TKU violates the Personal Data Protection Act or your personal data is stolen, divulged, modified, or damaged owing to any natural disasters, extraordinary event or circumstance beyond its control, OICSA, IMSGS, TKU will notify you by telephone, mail or e-mail, or post the notification at our website, whichever TKU deems appropriate, after conducting necessary investigations.

### D. Effect of Consent

1. By ticking the "I agree" box and signing this Consent, you confirm that you have reviewed, and understood, and agreed to all the terms of this Consent. If you breach any terms of this Consent, OICSA, IMSGS, TKU may terminate all the rights and services given to you whenever it deems necessary.
2. OICSA, IMSGS, TKU reserves the right to amend this Consent at any time. OICSA, IMSGS, TKU will post the amendments at its website and will not send a separate notification to you. Do not keep using the service if you object to the amendments. If you continue using the service, you will be deemed to have agreed to be bound by the amendments.
3. Unless otherwise expressly provided herein, no suggestion or information, neither in written format or orally delivered, that you may obtain in connection with this Consent.

### E. Governing Law and Jurisdiction

This Consent shall be construed and interpreted in accordance with the laws of the Republic of China.

## 淡江大學境外學生保險與健保投保須知

依據「外國學生來臺就學辦法」第 22 條中規定：外國學生註冊時，新生應檢附已投保自入境當日起至少六個月效期之醫療及傷害保險，在校生應檢附我國全民健康保險等相關保險證明文件。

前項保險證明如為國外所核發者，應經駐外館處驗證。

**為保障學生在校在台安全，未符合投保全民健康保險前，您必須被持續強制參加本校提供之「境外學生醫療保險」，保費共計新台幣 3,000 元（6 個月），此費用將在學費單內一併收取。**

外籍學生來台就學者，擁有居留證後並在臺居留滿六個月，指進入臺灣地區居留後，連續居住達六個月或曾出境一次未逾三十日，其實際居住期間扣除出境日數後，併計達六個月後，需在其就讀之學校或居住地區公所辦理參加全民健保。

另外，外籍人士可依附於有工作的配偶或直系血親，請至其配偶或直系血親的投保單位，以眷屬身分補辦理投保。

**全民健康保險係屬強制性保險，凡符合投保條件的民眾均應依規定參加全民健康保險。若不依規定參加保險，處新台幣三千元以上一萬五千元以下的罰鍰，並追溯合於投保條件之日起補辦投保；於罰鍰及保險費未繳清前，暫不予保險給付。上述罰鍰，經書面通知限期繳納，屆期仍未繳納者，移送強制執行。**

## **TKU International Student Insurance and NHI Insurance Information**

Following article 22 of 'International Students Undertaking Studies in Taiwan'. At the time of registration a new international student shall present proof of a medical and injury insurance policy which is valid for at least 6 months from the date the student enters Taiwan. Current student shall present written proof that they have joined Taiwan's the National Health Insurance Plan. The abovementioned written proof of insurance issued in foreign country shall be verified by the 'Overseas Agencies'.

**Before you qualify to Taiwan's the National Health Insurance, we are obligated to help students join the International student medical insurance provided by TKU University. The six months fee is NTD3,000.(This fee will be included within tuition payment.**

The international student who, after entering Taiwan and gaining an ARC, has stayed in Taiwan for six consecutive months, or exited Taiwan once for less than 30 days, with their actual period of stay amounting to six months after deducting the number of days that he or she has been away from Taiwan, may apply for NHI through their university or the local district office.

Foreign students with relatives who qualify as an insured person under the NHI program can enroll in NHI as dependents. (e.g.: With parents living outside Taiwan but grandparents living in Taiwan, the student may enroll as a dependent of the grandparents.)

**The National Health Insurance Program is mandatory; anyone who qualifies for the Program must enroll. Any qualified person who doesn't enroll is subject to a fine of NT\$3,000 to NT\$15,000. In addition, this person is required to pay the full premiums starting from the date he or she should have been enrolled. No benefits will be offered before the premiums are paid in full. If fined, a notice of penalty violation will be delivered in writing and the fine must be paid on time. If the fines imposed remain unpaid, after a given period of time the case will be referred to the courts for compulsory enforcement.**

- 3.Arrange for the transportation of my child, whether by ambulance or otherwise, to a proper facility where emergency medical treatment is normally administered, including but not limited to, an emergency room of a hospital, a doctor's office, or a medical clinic; 安排本人子女之運送(不論利用救護車或其他交通工具)，以前往適宜施行緊急醫療之場所，包括醫院之急診室、醫生之診療室或診所，但不以上述場所為限。
- 4 Sign releases as may be required in order to obtain any medical or surgical treatment as is required in the judgment of medical authorities at the facility.於醫療機構中為獲得相關醫療或手術，得簽署任何經醫療機關判斷後，所要求出具之相關文件。

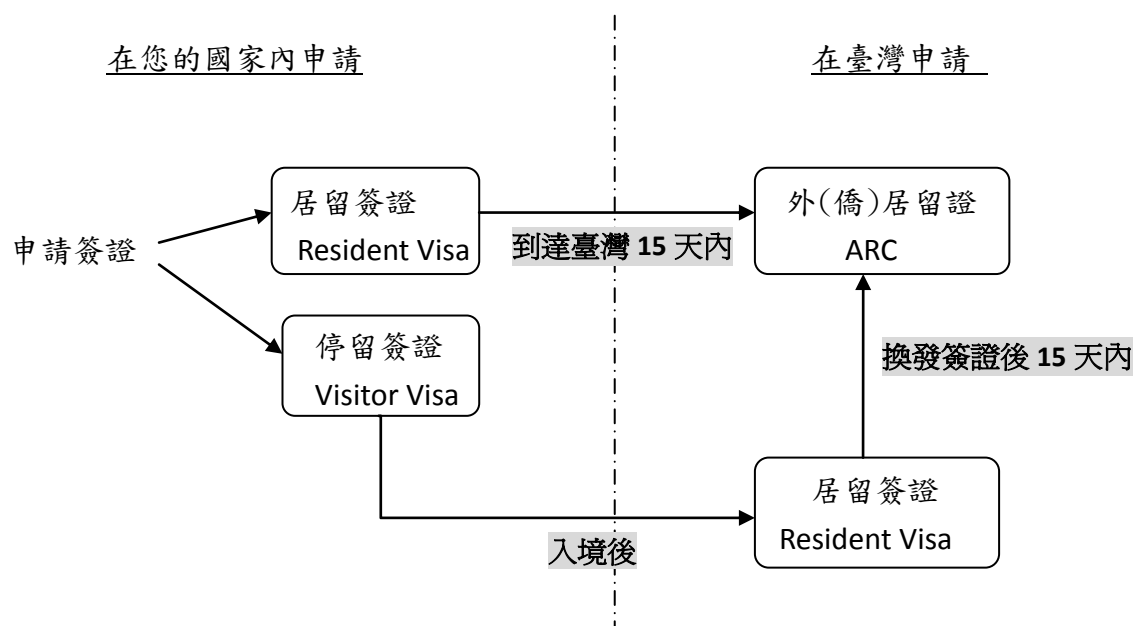

## Visa Information

Before coming to Taiwan, you must apply for a Resident VISA in order to enter the country. Locate the **Taipei Representative Office** closest to you using the following website: <http://www.mofa.gov.tw/Official/Home/Index>

After you enter Taiwan with a Resident Visa, you need to change it to an Alien Resident Certificate (ARC) at the National Immigration Agency **within 15 days of receiving your Resident Visa**.

Alien Resident Certificates (ARC) must be extended at the National Immigration Agency before the expiry date.

If you don't do so before the expiry date, you may: 1. be fined, 2. have your residence qualifications suspended, or 3. be deported from Taiwan.
